#### 3. Update by the President

President Eliasch informed on matters relating to the centralization of media and broadcast rights.

This was followed by a Q&A session.

#### Special distribution relating to the Infront agreement

President Eliasch stated that questions have been raised by non World Cup associations, what the benefits are to them. As per the FIS Strategic Plan the centralization should benefit all of the FIS family.

President Eliasch mentioned that the 30 million CHF which President Eliasch had negotiated to receive from Infront in lieu of FIS' strong legal position was entirely separately negotiated and thus bifurcated from the terms negotiated for the media rights. It was therefore proposed that those 30 million CHF is distributed equally to all full member NSAs in the coming three years to support the development activities of the FIS Strategic Plan.

The <u>Council unanimously agreed</u> that provided the Infront agreement is executed, the amount of 30 million CHF is distributed in equal amounts to all NSAs in three instalments 2024-26 to support the development activities of the FIS Strategic Plan, which should be communicated accordingly.
