Several guests from NSAs were present at the meeting.

4. Approval of the agenda

The agenda has been sent on 13.08.2021 and is approved.

5. Approval of the minutes of the meeting Sub-Committee for Rules and Control Cross-Country, Zoom platform, 10.05.2021

The minutes are approved.

6. Report and information from the FIS Race Director

No report from the FIS Race Director. Several items were discussed during the meeting.

7. Recasting of the Working Groups

S:C. chairman Uros Ponikvar proposed to change the principle of the working groups. In order to encourage the discussion and commitment of the S.C. members, some working groups will be replaced with specific tasks assigned to one leader. Persons from the Sub-Committee or from the outside can be invited to join the discussion. If no member of the Sub-Committee volunteers to lead the task the Sub-Committee Chairman can search for a person outside of Sub-Committee.

Homologation Working Group should be kept, as its field is very specific. Allan Serrano (USA) is proposed to keep coordinating work with Regional Homologation Coordinators.

Report from the leader of each task is expected at next meeting of the Sub-Committee. Any proposals for the S.C. should be sent 1 month prior of the meeting.

The proposal was approved by the Sub-Committee.

8. Proposals and issues from other Sub-Committees

- Proposal from Sub-Committee for Rollerskiing to update jury composition at WSC/WC level (will be addressed later)
- Proposal to include a race at end of June into the FIS Rollerski World Cup Calendar a competition in Telermkveka (NOR) on 24th 26th June, 2022. The FIS season starts on 1st July. The proposal is to give exception to this competition to be included in the 2023 season. The Sub-Committee agreed that it is a political decision, which should be addressed to the Cross-Country Committee.

9. ICR matters: Precisions/ Guidelines

The Sub-Committee dealt with following proposals (full wording in the attached document):

Jury composition at WC/WSC/OWG

Jury composition at ROL WSC/WC

Obstruction and overtaking rules and updated decision chart

- IRM Ranking
- Cancellation and validation of events in case of force majeure situations
- Possibility to appeal a Jury decision

In special situations it would be desirable that an independent body can appeal a Jury decision, should the imposed sanction is considered as not sufficient. It is a sensitive task, which needs to be discussed carefully. Anna Rosa (ITA) volunteered to lead the discussion.

All proposals were approved.

10. FIS Points

Pierre Mignerey raised the issue of misuse of FIS points during the qualification period for the OWG. The FIS points system has been working well, but it would be good to look in the system and find out if there are any issues with the FIS points calculation. An analysis should be made, report is expected at the next S.C. meeting at its spring meeting in 2022.

Petr Mach (CZE) volunteered to lead this project and will contact persons that expressed their interest to cooperate.

11. Homologation matters

Allan Serano reported to the Sub-Committee about homologation matters. Detailed report is in the attached document.

The Sub-Committee approved the proposal.

11.1 Homologation of long distance courses

An issue about FIS competitions held on long distance courses of unusual length (e.g. L31,5 km, 90 km). Homologation parameters such as TC, MC and HD are not according to ICR. However, those courses are regularly used for competitions.

The Sub-Committee should decide if FIS races on such courses should be organised and FIS points awarded? If yes, then it should not be an exception but rules should be adjusted.

11.2 Other homologation matters

Homologation seminar will not take place this autumn. The plan is to use more sharing of knowledge rather than a few persons presenting to the audience.

Regional homologation inspectors should be identified and homologation inspectors list should be updated.

Update of the homologation software is possible but an official request has to be made. Budgeting has to be done.

Rollerski courses homologation should be made in the future, with FIS Rollerski homologation guideline.

Pierre Mignerey informed the Sub-Committee about the proposal from WSC Organiser Planica 2023 to organise 30 km and 50 km mass start competitions with a start in Tarvisio (ITA). First 13-15 km after the start are relatively flat, There were two possibilities along the course where a climb could be found, however, such a solution would require big costs and environmental impact and it should be avoided. At the same time, a lot of work on the width and safety of the course has to be done in order to secure safe and fair competition. The Sub-Committee did not have any comments about the proposal.

12. TD matters

Len Appedale was excused from the meeting; the TD report was not delivered but will be sent to the S.C. later.

Issue regarding TD nominations for popular competitions was discussed. The list with TD nominations should not be published until assignments have been confirmed by TD and TD Assistants. Assignments of National TDs should be done in cooperation with the regional TD coordinators and respective NSAs.

TD seminars

- Eastern Europe seminar one week later than planned (12th 14th October), not in Zakopane, place TBC.
- Western Europe October 16th only online seminar. Rules update only ordinary biannual seminar will take place again next year.
- Scandinavia online seminar from 6th 7th November.
- North America online seminar 5th 6th November, 5-6 part B candidates
- A/NZ TDs from A/NZ region would like to join one of online seminars (depending on the time difference).
- Far East online, 29-30th October

Learning from C-19 pandemic is that it is possible to host online meetings and seminars. However, it is still very valuable to have a chance to meet in person. The proposal is to organise TD seminars every year, but every second year there should be one day online update. The distribution of onsite seminars should be even (not all in the same year).

A solution how to make exams using an online tool should be evaluated. There is experience in other FIS disciplines, which should be explored.

TD nominations

There are no changes to the TD nominations for the big events for the upcoming season. Mike Norton (CAN) was nominated and approved by the S.C. as the Jury member at the FIS WSC Planica 2023.

Should it be necessary, jury nomination for the JWSC & U23 WSC 2022 will be changed, depending on which NSA will host the event.
