4. Appointment of a secretary

Reed Zuehlke (USA) was appointed secretary.

5. Approval of the agenda

The agenda was unanimously approved as distributed.

6. Approval of the minutes of the obmen meeting, August 27, 2022

The minutes of the previous obmen meeting were unanimously approved.

7. Approval of the minutes of the Spring 2023 subcommittee meeting

The minutes of the Spring subcommittee meeting were unanimously approved.

8. Opinion on the work of Jumping Judges

Chairman Greger deferred much of the discussion on judging to item 10 on the agenda. He did comment that overall, judge scores showing on the nations list are lower, but there are more judges on the list than in prior years. He said that the list is much larger than it should be.

National judging

In 2022/23 only one judge exceeded the 10.00 limit on the national judging assessment list. This year four judges have exceeded that limit – PERKTOLD Wolfgang (AUT), JUSTIN Anton (SLO), KANEKO Yusuke (JPN) and INOUE Ryuichi (JPN). These four judges will not be permitted World Cup assignments for the upcoming season. In addition, this is Mr. Anton's second offense. He will not be permitted World Cup assignments for one additional year (total of two years).

The respective Obman is required to speak with any judge who has received 5.00 or higher on the national list below to review judging rules and guidelines.

9. Opinion on the work of TDs and TDAs

General

Chairman Greger began the discussion on TDs and TDAs by sharing that TD work overall is at a high level of performance. However, some good TDs have either retired or began working as FIS professionals. As a result, some newer TDs will be moved to the World Cup level – preferentially retired top athletes.

Georg Spaeth (GER) will now be on the World Cup Ski Flying team. Andi Bauer, a former top athlete and coach, will now be in the TD group. Jernej Damjan will also be in the TD group. Alex Diess will remain in the TDA group.

Because gender equality has been strongly supported by Norway, the chairman asked why Norway does not have any women TDs. The current lack of strong women TDs requires FIS staff (Renata Nadarkiewicz and Dorota Szczepanek) to fill those roles for important events. Ski Flying for women will soon be a reality. Unfortunately, specializing in Ski Flying takes a great deal of training so we are already far behind. Nevertheless, this is a good opportunity for qualified women to move up quickly.

Late start due to equipment problems

Athletes often report they are having equipment problems. In the past the Jury has allowed them to start later in the order. Since the Jury will never have a complete understanding of the circumstances surrounding the equipment issue and the public does not understand why an athlete starts late, this process should end. These athletes are professionals and need to be prepared to start, so if they do not come prepared to start on time they will be disgualified.

60 second vellow phase

Feedback on the 60 second yellow phase has been positive, but the longer time athletes are spending sitting on the start bar demands that the start bar meet more stringent requirements for athlete comfort. As a result, start bar evaluation by the Jury will be required and start bar measurements will now be part of the TD report.

TD reports

Inclination at and around HS and start bar measurements

Athlete safety – especially with long jumps – is an ongoing concern. To ensure actual measurements comply with the homologated profile, TDAs will be required to measure the angle of the landing surface before, at and after the HS this winter. TDAs should be aware that accuracy of the measurements requires a two-to-three-meter bar. A one-meter bar is insufficient.

Jurgen Winkler (AUT) noted that TDs must work together with hill crew to ensure they understand how and why to measure if they are being used to help measure angles around the HS, because without the proper equipment it can be dangerous for TDs/TDAs to climb out on the hill.



To close out this topic the chairman brought up two incidents from competitions during the Summer Grand Prix (SGP):

- Szczyrk Geir Steinar Loeng (NOR)/Jernej Damjan (SLO)
- Szczyrk Alex Diess (AUT)

Szczyrk, POL

The final round of the SGP Women's competition was cancelled by the Jury due to challenging weather conditions. This decision was not discussed with the RDA or RD before communicating it to the broadcaster, coaches and athletes. The Jury was also not available to discuss the situation with Competition Management after the event.

Information on the situation was acquired from RDs Sandro Pertile and Chika Yoshida and TD Geir Steinar Loeng (NOR), but a decision on whether action should be taken against the Jury is awaiting feedback from RDA Miran Tepes, who has been unavailable due to his travel schedule. The TDA for this event was Jernej Damjan (SLO).

During the SGP event in Szczyrk, POL, Alex Diess (AUT) actively played a role as coach for the Austrian team. While an explicit rule forbidding a FIS official from acting as a coach is not included in the ICR, it is clear that FIS officials should act in an unbiased manner and any coach acting in an unsportsmanlike manner can be sanctioned. Mr. Diess was clearly acting in an unsportsmanlike manner when he chose to perform the role of TDA and coach for the Austrian team during the same season and doing so in a competition at the highest level.

Mr. Diess stated in an Email message to the chairman that he was unaware of the conflict of interest caused by his simultaneous roles as TDA and coach for team Austria during the season. The message is included below. A course of action to be taken against Mr. Diess has not been determined at this time. However, any subsequent conflicts of interest will result in sanctions against him and potentially even the Austrian team.

then Horst asked me after the TCM if this couldn't be a conflict with my TD work but it was so far away from my thinking that I simply didn't realize because I was only looking at it from my point of view with all the respect in the group of colleagues and coaches I had no bad thoughts

10. Working Group "Judge Performance"

Women's Ski Jumping - Kjersti Espelid (NOR)

A working group of 5-6 members has been evaluating the differences between Men's and Women's judge scores. Klaus Dobrezberger (AUT) leads the group but was not present for the meeting. The group, formed during the 2022 judge seminar in Grainau, GER, was tasked with determining whether Men's scores are higher than Women's scores for the same performance. Kjersti Espelid (NOR) provided feedback on the group's analysis and findings.

- Style points for the analysis came from the same hill
- There is a difference in style points between men and women
- Flight Phase there are more deductions for women
- Landing there are more deductions for women, but this is due to poorer Telemark landings
- Outrun there is no large difference between men and women
- Overall, the differences are predominantly in the landing phase

Erik Stahlhut (GER) presented data from the same competitions based on judge scores from those present and from the "Super Judges" demonstrating that the differences in judge scores are a result of poorer landings on longer jumps. This conclusion is supported by the analysis from FIS Expert Mr. Soren Muller. Mr. Muller showed during the spring meeting that women experience a higher flight curve to achieve the same distance and therefore the impact force is greater for women than men, making it more difficult for women to execute a proper Telemark landing in comparison with men at the same distance.

Based on the independent analyses performed by the working group, Mr. Stahlhut and Mr. Muller, the conclusion is that judges are not biased and the difference in judge scores is due to performance. The members agreed that



there is no need to continue analyzing judge scores for this purpose. However, coaches, athletes, the media and the public should be informed of these findings.

Reed Zuehlke (USA) recommended that the Jumping Committee deliver this message to the coaches and leverage some of the scientific findings from Mr. Muller's analysis as an explanation. Marit Stub-Nybelius (SWE) suggested the Jumping Committee inform the media as well. The chairman asked Mr. Stahlhut to be present at the fall Jumping Committee meeting to convey his findings to them in person. Mr. Stahlhut agreed to be present.

Virtual Judge analysis – Erik Stahlhut (GER) Analysis from COC – EWOXX data

In a continuation of the work Mr. Stahlhut has been doing to evaluate judge performance, he shared a deeper view of how the virtual judge system can assist with the following three objectives laid out by chairman Greger at last year's meeting:

- 1. Train judges
- 2. Evaluate onsite judge performance
- 3. Review judge performance obmen can view all scores

Before beginning his explanation of the data, Mr. Stahlhut posed a question to the group. "If a judge has been removed from World Cup, when SHOULD he/she be able to return?" EWOXX has all of the data from Continental Cup competitions, but until now it has not been made available for analysis. EWOXX will be providing that data from now on so judges can be evaluated and compared to understand individual judge performance. The current judge performance reports use averages and rounding to determine judge performance. With the raw data – actual scores – areas of deviation can be observed where rounding often shows full compliance.

Additional analysis can be performed using actual scores that could not be done without a significant amount of manual data entry effort to answer some new questions:

- What if scores are too high for all judges?
- What if scores are too low for all judges?
- What if there are no or few athletes from the judge's own nation?
- What if scores are correct for athletes from the judge's own nation, but too low for all other athletes?

Judge tendency is the real question to ask...what is the judge doing overall as compared with the correct scores for a jump? And what impact does that have on the overall results? Dividing jumps into groups based on post competition ranking will help determine the impact a judge has or will have: 1-5, 6-10, 11-20, etc. Incorrect scores for the top jumpers has a greater impact than it does for those lower in the ranking.

Kjersti Espelid (NOR) remarked that unless we have the virtual judge scores we cannot know what the correct score should be. Marit Stub-Nybelius (SWE) asked if the focus should be on all scores or only those with "National" impact



and for one competition or all competitions. Reed Zuehlke (USA) stated that we don't have a "correct" score for COC or FIS Cup so other statistics are necessary to help educate these judges. Mr. Stahlhut mentioned that judges will always make a mistake on one or more jumps. That is not important, but what is important is the tendency of how that judge scores jumps.

Saso Komovec (SLO) said that ratios between the first five and the next five are not the same. The top jumps are the most important so we need to avoid focusing on just one judge. The chairman noted that one mistake does have a greater impact in the top five, but that judge could be thrown out. Mr. Stahlhut clarified that the top five group is actually 10 jumps (two rounds), so the single judge tendency would be calculated for the entire group not just one jump.

Chairman Greger reminded the group that the focus needs to be on the athletes and not the judges when taken overall and the evaluation we are doing has to be easy to explain to others so we can avoid conflict as we implement it.

Virtual Judge participation

To encourage participation in the virtual judge system and accumulate the number of scores needed to provide effective analysis, the top three most active judges will each receive an additional personal assignment. This past season three of the top four were from Japan. Unfortunately, Mr. Ryuichi Inoue is on the nations list, so Mr. Tadahide Matsuura will be taking his place. A list of the top six is included below.

11. ICR 431 and the Deduction List

In an effort to simplify the judging criteria and help differentiate athletes with good Telemark landings from those with less effective Telemark landings, a group of judges has been working on a rewrite of the deduction list for the past several years. A version of the list below was introduced at the spring meeting, but not fully evaluated.

Reed Zuehlke (USA) presented an updated version of the list to those present for discussion. Mr. Zuehlke pointed out that the emphasis should be on the correct movement and not the position of the feet. The group felt that the term "SAFE Telemark" would help emphasize the movement rather than the position, but the members pushed back saying that "SAFE" was too nebulous a term to describe the intention.

Max. 5.0	Landing Deduction

Rows 1 and 2 in the table are mutually exclusive – either there is a TELEMARK or there is NO TELEMARK. Deduction points from the other rows would be in addition to the score given for the TELEMARK.

After a lengthy discussion of the wording in the table, the members decided that it would take a great deal of time to transition to this type of approach. The chairman suggested to the membership that a "NO TELEMARK" landing score should be

changed from a 2.0 point deduction to a 3.0 point deduction to help move us in the right direction. The membership agreed that it should be planned for a change following the next (2024) judge seminar in Grainau, GER.

12. IT Tools

FIS online education tool

Ski Jumping uses a tool from the Moodle website – https://moodle.com for online education – https://elearning.fis-ski.com. It has been recommended that Ski Jumping migrate to this common platform for development, support and maintenance purposes. FIS Ski Jumping officials are requested to provide any meaningful feedback to the chairman on whether this new tool can be quickly adopted or will require a lengthy transition period.

Updates to judging videos

Judges have been requesting updated videos on the eLearning website because the ones currently posted are from many years ago. Ole Walseth (NOR) and his team of judges have put together a package of jumps to replace the current ones.

Dear President, Dear Secretary General,

In reference to the decision of the FIS Council on 24 May 2023 to increase the per diem for FIS officials (TDs and judges) in all disciplines and on all levels which has been communicated in the minutes sent to you on 13 June 2023, we would like to confirm as follows:

- The per diem for TDs and judges increases from 100 to 125 CHF.

Due to challenges with availability of time slots from broadcasters, a rule will be introduced to start a competition without a trial round or Qualification round if at least one round of official training has taken place.

World Cup Rule Changes - Men and Women

A significant number of changes to the World Cup rules were included in the minutes of the spring subcommittee meeting. These updates can be found in the FIS Cloud as well.

Other rule changes



SCE

The guidelines for competition equipment accompany this report. Pertinent changes for the upcoming season are included below.

2. Jumping Ski Bindings

The use of a safety strap connecting the boot with the binding/ski is mandatory unless a binding with a locker system is used.

3. Ski Stopper

Ski stopper is a mechanism that prevents the ski from sliding down/away and lowers its speed when the boot is released from the binding,

The use of ski stopper is mandatory in all FIS competitions (from winter 2023-24.

3.1.3 Thickness of the sole

The boot sole may not exceed 40 45 mm measured from inside to outside at the lowest point of the heel.

The entire height of the boot sole and binding wedge must not exceed 50 70 mm.

3.1.5 Back part

Thickness of the back part of the boot at the highest edge must not exceed 30 80 mm including the wedges if these are worn. Towards the heel the design of the rear part of the boot must be wedge shaped. Thickness of the sides must be equal with a maximum thickness of 15 mm. Maximum circumferences around the ankle joint position (12 above bottom part of the boots) must not exceed 45 cm.

4. Ski Jumping Suits

The zip must end minimum 5 cm below the waist seam of the suit.

Leg hem must be cut horizontally straight across the width of the strap at the same height. The leg hem must not exceed in length the lower sole of the ski jumping boot. The width of the strap must be min 2 and max 4 cm. The width of this part of the leg must not exceed respective strap width. The strap must be placed at 90 degrees angle to the boot sole and in line with the leg panel seams. symmetrically around the boot during the jump. The leg of the suit cannot be fixed to the boot in any other way than with the strap.

The intersection of seams at the armpit must be the lowest point. The shape of the cut in the armpit must be rounded.

During crotch control, measured crotch height must be no shorter than the measured crotch length of the athlete +3 cm.

The intersection of seams at the armpit must be the lowest point. The shape of the cut in the armpit must be rounded.

4.2 Air permeability of the suit material

The maximum difference between various parts during the control must not exceed 12 litres.

4.3 Underwear

The underwear is consisting of two parts (shirt and pants), made of elastic material. No zipper, buttons, Velcro or similar on the T-shirt are allowed.



Fluor Ban

The Flour ban project is led by Mr. Augusto Gulio (FIS) and testing has already begun starting with the European Games in Zakopane, POL. Testing takes place in the start area and at the exit gate. Positive test results from the SGP in Courchevel, FRA have been sent to the laboratory for evaluation. The results are pending. Additional tests will occur at the COC event in Stams, AUT and the SGP in Klingenthal, GER. Unannounced controls will be performed throughout the winter season. Any positive tests will result in either NPS or DSQ.

Chief Video Distance Measurer

The 2023-24 season will be the final season for nominations of Chief Distance Measurers. This position is being eliminated to allow for the addition of a second Equipment Controller. Rules applying to this position will be removed from the ICR at its next publishing.

14. eLearning for Chiefs of Competition

Hubert Mathis (SUI) will no longer be the leader of the eLearning Education and Coaching Program (ECP) for Chiefs of Competition. Mr. Mathis has accepted a role with the FIS as FIS Cup Coordinator, so Kristian Brenden (NOR) will now lead the program. Sandro Sambugaro (ITA) has also joined the team.

The next online Chief of Competition theoretical exam will take place on November 4, 2023. Upcoming workshops will take place in Klingenthal, GER, Sapporo, JPN and Lake Placid, USA.

16. Examination lists of active Jumping Judges and TDs

Obmen were asked once again to verify their respective lists of active judges and TDs and send the names of any inactive officials to the chairman as soon as possible so they can be designated inactive in the database. The obmen were also asked to ensure that all officials update their contact information in the database as quickly as possible.

17. Nomination TDs and Jumping Judges season 2023/2024

Chairman Greger sent a nomination list with TD assignments to the obmen during the meeting. The obmen were requested to submit all judge assignments by the beginning of September.

Final nominations for the 2025 World Championships and 2026 Olympic Games should be submitted by the 2024 Spring subcommittee meeting.

- Do we need to keep wind/gate compensation for FIS Cup?
- Is a cloud solution the best answer to address hardware costs and low IT skills?

On behalf of the Norwegian Ski Association and the "K-Jump" system, Ole Walseth (NOR) introduced this new candidate for a data service/video measurement FIS license from Norway. Similar to PRIOT, the K-Jump system is intended to provide a lower cost solution for Continental Cup and lower-level competitions.
